The information collected on this form will be used for the sole purpose of administering the Rules, Regulations and By Laws of the OHF and/or for the purpose of registering the individual in the program for which they have enrolled and may be used to provide them with the information necessary for participation.

OHF Regulation E65 - Minor Hockey Transfers (Residential Moves) within OHF Branch

- a) The OHF Minor Hockey Player Transfer Form (For Residential Moves) must be carefully completed and submitted with all required supporting documentation including: Official Confirmation of School Enrolment and a Letter to School Authorizing the OHF to check on Registration during year; Copy of Rental Agreement or Home Ownership Papers; Copy of Parents' Drivers Licence; Copy of a Bill with parents name and new address; and Statement of why they are moving. Should any of the required documents not be available a sworn affidavit may be offered in its place.
- b) Upon Member Partner approved receipt of the complete application with supporting documentation the player's residential move is conditionally approved to participate in the OHF during the approval process; however, any false information contained in the form may result in penalties against the player and/or team and/or Member Partner.
- c) This form must be completed and documentation provided when a player was resident in the previous season with a different minor hockey Member Partner (e.g. OMHA, GTHL, NOHA, ALLIANCE) or Association other than the one with which he/she is resident with this year by way of a residential move.
 - a. This form is not required when the player does not change residence but registers with a different minor hockey Member Partner (e.g. AAA Waiver).
- d) The player must complete this form. The completed form, accompanied by all supporting documentation, is to be submitted to the minor hockey Member Partner the player is moving to.
- e) If the transfer is between two associations within one Member Partner's residential jurisdiction then the Member Partner will deal with the transfer form with the two associations involved. No OHF involvement is required.
- f) If the transfer is between two associations from different OHF minor hockey Member Partners, the forms shall be signed by the registrar and forwarded to the OHF office with all accompanying documents.
- g) The player's previous minor hockey Member Partner shall have seven (7) days, upon receipt, to either approve the transfer, or reject the transfer. In the case of rejection, the reasons therefore must be stated under the OHF Constitution. Any rejection without reasons shall be deemed to be an approval of the transfer.
- h) The OHF Executive Director, upon written request for relief, may authorize an extension of the seven (7) day period.
- i) Should the OHF not receive a reply either approving or rejecting the request from the player's previous minor hockey Member Partner within seven (7) days, the request will be deemed to be approved, and the OHF shall notify the appropriate Member Partners of the approval of the residential transfer.
- j) Applications that are rejected may be referred to the OHF Registration Committee as per OHF By-Laws 3.28-3.35.

Important Dates

December 15: Final signing date for imports in the Lake Ontario Region.

January 10: Final release date for players in order to be able to register with another team for the current season.

January 15: Final signing date for non-imports in the Lake Ontario Region.

February 10: Final date to register players for the current season.
