Brochures provided and a small presentation was made to the group

2) Record Presence of Associations -

49 teams registered this last season (60 teams declared originally). Restructuring occurred in all Associations: 750 players participated-770 games played this season and only 3% of games, in total, had complaints filed. Generally, overall satisfaction from teams.

3) Welcome – Joe McColeman, President

The League sought input from the Associations for what changes they would like to see, if any....good communication provided on an as-needed basis throughout the year, but the associations are not requesting any changes; invited local AAA teams back into the League...still waiting for replies;

The League's Playoff Tournament ran 14 Championships (also 2 in midget playoffs outside the tournament) and all teams appeared to enjoy the format once again. The only complaint received was from some selective parents, etc., that the League offers too many championships, which is really hard to understand!

Lots of volunteer assistance, aside from the NDHL Executive, during tournament including Al Cross and Brian Kuruliak as well as assignment of officials by Mike Creasey and Randy Pascal to name a few.

Introduction of Executive- Executive 2013-2014 introduced

There will be many changes for this yr., as many of the existing Executive are moving on to other interests. It should be pointed out that they have provided many years of leadership, and notably only one member actually had children participating on any teams.

Many thanks to departing Executive, who in their entirety have provided over 33 years of Executive involvement...Carol Welch (Vice President), Dave Laporte (Treasurer), Pam Hull (Director), Glen Polsky (Director and Convener) all moving onto other personal endeavours.

As a comment, all Associations have been extremely happy with this Executive.

Special guests introduced- Jiggy Jamieson (NOHA President), Claudette Myre (NOHA 2nd Vice) and Gail Payette (NOHA Council Director District 7); this year their is a big turnover as well at the NOHA...numerous openings in their Executive.

 - 1. Request as a guest to ice a Midget team based out of Warren. Have applied to NOHA for Rep status. Team Review Committee to deal with this.

Suggestion by Manitoulin to have the League consider carrying only a minor midget division so that the High School team will carry the second and third year midget players. This scenario may be difficult with the Sudbury area teams/schools as this working relationship does not exist.

1. Meetings (Voting)

Proposed by Manitoulin (Craig Abotossoway/seconded by Dan Charette)

Deals with amending voting to include changes to Rules and Regulations....not just the constitutional amendments.

Rules traditionally have been on an adhoc basis which makes it easier for the Executive to manage the league during the year. Associations have always been given 14 day's advice and an opportunity to provide input on Rule changes already.

2. Convenors/Committees

Proposed by Manitoulin (Craig Abotossoway/seconded by Dan Charette)

Deals with having the Review committee have equal representation from Region A – Sudbury, CC, and SDG and Region B – outlying areas; also deals with the Review Committee taking into account many considerations including a team's

good standing within the League, etc. In order to approve or not approve teams for each season.

The Executive's response is that this process is already done. Review Committee meets May-June each season; each team is reviewed for player caliber and development as well as coaching qualifications; team records are reviewed but also problem teams are reviewed, local knowledge is considered; requests are sent to some teams to prove that their caliber will support them in the League, etc. The Executive acknowledges a general request (implied by Manitoulin) to communicate it's reasons more thoroughly, if needed.
